**1.0** Call to Order and Roll Call.

Meeting was called to order at 9:02 a.m. Full quorum was established with all members present.

- **2.0** Approval of the minutes of the Structural Subcommittee regular meeting of May 10, 2022. There was a motion to approve as written. Seconded and approved.
- **3.0** Discussion and possible action regarding California code adoption cycle changes as it amends the 2022 San Francisco Building Code (SFBC) chapter 16, 16A, 17, 17A, 18, 18A, 19, 19A, 20, 21, 21A, 22, 22A, 23, 33, 34, & 34A and appendix C, I & J.

#### Discussion:

- DBI Technical Services Manager Michelle Yu made a presentation regarding the proposed changes to these SFBC chapters.
- Michelle Yu presented a table listing sections or chapters with substantive changes and administrative changes.
- There was a discussion regarding SF amendment to Section 1607.1 vehicle loading.
  - International Building Code (IBC) section 1607.20 sidewalks, vehicular driveways, and yards subject to trucking was mentioned.
  - IBC doesn't refer specifically to the American Association of State Highway and Transportation Officials (AASHTO) or the 10,000 pounds.
  - The proposed San Francisco amendment of Section 1067.23 will be renumbered to Sec. 1067.20.3.
  - o IBC Sec. 1067.20 will be revised to add "or vehicle loading".
- There was a discussion regarding SF amendment Section 1705.4.3 Architectural components.
  - The section will be renumbered to 1705.13.5.
  - Phrase of "appendages, and ornamentation" will be added to the sec. 1705.13.5.
  - Exception 1 and 2 were revised to incorporate San Francisco amendments.

**Action:** There was a motion to approve the proposed 2022 SFBC Chapters and appendixes and move it forward to the CAC. Seconded and approved.
