Three draft Administrative Bulletins: AB-098 on Post-Earthquake Repair and Retrofit Requirements for Multiunit Wood-Frame Residential Buildings, AB-099 on Post-Earthquake Repair and Retrofit Requirements for Concrete Buildings and AB-100 on Post-Earthquake Repair and Retrofit Requirements for One- and Two-Family Dwellings of Wood-Frame Construction are discussed.

Possibility of combining AB-098 and AB-100, deleting the repair details, emphasizing the retrofit triggers and adding FEMA P-807 (if published) as reference in lieu of ATC 71-1 are also discussed.

A special meeting with attendance of Laurence Kornfield in two weeks is suggested.

AB-078 : Criteria for Waiving Special Inspection Requirements for Signs and Awnings

Draft #4 is discussed.

The last paragraph is revised as follows:

“For signs less than 24 sq. ft. in area but exceeding the weight and projection limits above, ~~engineering calculations and special inspection on welding are~~ is waived.....”

A motion to approve AB-078 as revised and forward to CAC. Seconded and approved.
