The notice of protest must be received by the Department of Building Inspection by 12:00 PM PST on Tuesday, November 28, 2017 and must include a written statement specifying the grounds asserted for the protest. The protest must be signed by an individual authorized to represent the Proposer, and must cite the law, rule, local ordinance, procedure or RFP provision on which the protest is based. Protest or notice of protest made orally (e.g. by telephone) will not be considered.
