

# ACCESS APPEALS COMMISSION MINUTES Regular Meeting Wednesday, February 23, 2011

## 1. CALL TO ORDER AND ROLL CALL

The meeting was called to order by President Ellsworth at 1:05 P.M.

#### 2. REVIEW AND APPROVAL OF MINUTES:

The minutes for the December 22, 2010 meeting were approved unanimously, with amendments requested by Commissioner Brown.

## 3. REVIEW OF COMMUNICATIONS ITEMS:

Secretary Fessler reported the status of pervious appeals at 555 California and 300 Jefferson. 555 California Street permit application has been approved by the Planning Department and presently under Building Department plan review. The Port of San Francisco has resolved the accessibility issues related to 300 Jefferson Street application. Copies of the 2011 code books were available to the commissioners.

## 4. NEW APPEAL #11-01

## **50 CALIFORNIA STREET**

The appeal was moved off the consent calendar by Commissioner Park. The appellants' representative, George Soskin, agreed to have the appeal heard at this time. Mr. Soskin testified that the present parking configuration has not changed from the past appeals. He requested the commission grant a continuation of the unreasonable hardship as stipulated in past appeals.

The buildings' representatives described the parking level had 75 total parking spaces, of which 3 were accessible. The parking was valet in nature with the accessible spaces closest to the basement elevator lobby, allowing persons with disabilities to park themselves or use the valet.

The commission considered the cost of building renovations over the past three years has put the building over the threshold amount for full compliance. The secretary provided cost of renovations for the previous two years instead of three. The total cost of building renovations from 2009 to the present was 5.4 million dollars. The cost to provide the required 98 inch clear height is estimated to be 1.7 million dollars.

The commissioners were concerned that the sign at the garage entrance was not readily visible from the street, and prior to reading the sign, drivers may enter the ramp and get trapped. The commissioners questioned if the present signs were adequate.

Commissioner Park motioned to continue the appeal to March 9, 2011, with the stipulation that four items be addressed. 1) The appellant research the availability of leasing fully complying van parking within 300 feet of the building entrance. 2) Possible improvements to signs which direct drivers to the location of accessible spaces. 3) Cost of building permits for the previous three years. 4) Provide the Commissioners the opportunity to visit the site. The motion passed.
