1. Call to Order

The meeting was called to order by Scott Walton at 9:15 AM.

5. Extension of the SRO Task Force beyond December 31, 2012 Resolution No. 582-10. -Discussion & Possible Action

Scott Walton commented on the Legislation that created the SRO Task Force will sunset this year, and Rosemary Bosque has already contacted the Board of Supervisors, and wants to make the Task Force members aware that if the Board of Supervisors does not extend the SRO Task Force the Task Force will officially end December 31, 2012.

Scott Walton stated that when this legislation was adopted, it was to design a Task Force that would simplify and function as a group.

She further commented that there will be a hearing held on November 29, 2012 to discuss the increase of rate and changes to lifeline services, such as landlines (telephones) and cell phone.

Angela Chu commented that there organization has money for affordable housing, and that the SRO collaborative is looking for housing opportunities to provide for their clients.
